Surrey Chambers update

2021-2022

Another unusual year for the Chamber- although more opportunities for us to support businesses through the continued challenges of:

- Covid.
- Brexit
- The war in Ukraine and resulting supply chain issues
- Recruitment crisis
- Cost of living crisis
- Uncertainty in the political arena

Surrey Chambers Team

The Surrey Chambers team has continued to support businesses with much information, signposting and creation of helpful support. Some examples are:

- Second cohort of the Start-up Academy ran successfully with some fantastic feedback. Not only did the delegates get a huge amount out of it but a significant amount of work was also created between delegates and between delegates and expert presenters.
- Surrey Business Accelerator was created bringing 4 investors in front of 50 business owners who are still in the process of bidding for investment. This will continue with more investors and more business owners coming together.
- What started as a small project, supporting the Kickstart scheme became a significant area of activity. 400 young people were placed with Employers, and we already know of 30 who have been retained (More info to be gathered) and 20 who went on to other full time jobs



 We are now offering the full International Trade service with CustomDeclarations included although there have been some reductions in IT due to the many issues already mentioned

 Massive thanks to the Council of Surrey Chambers who have continued to feedback on what was happening on the ground which we have been able to share with various Ministers and Civil Servants

Membership

- Membership has started to grow again after a dip last year.
- Once again we have not introduced any increases this year to keep our membership affordable
- The Executive Partner membership has grown to nearly 20 and they have enjoyed a series of exclusive events bringing some of the larger companies together to discuss topical subjects in great venues.

Events

- We have returned to a great program of face to face events welcoming over 250 attendees over the last 6 months
- The Surrey Business Awards have been launched this year with the celebration event taking place 3rd November

Projects

- We have been successful with a couple of projects for Woking BC delivering events and an International Trade Forum
- Surrey Chambers has taken the Employer Representative Body lead on a Local Skills Plan for Surrey, which essentially enables businesses to have as much say in what training provision is available locally. We await designation but once that is granted the Chamber will be reaching out to all businesses for input.
