A Certificate of Origin of a responsible body in the country of export **OR** a copy of the invoice from the manufacturer **OR** a declaration by the actual producer or manufacturer of the goods **OR** a copy of the import entry against which the goods were cleared by HMRC.

NOTES FOR GUIDANCE IN COMPLETING CERTIFICATES AND APPLICATIONS

Box 3 Country of Origin

- (i) For goods of European Community origin Insert "European Community". Where all goods originate in a particular Member State of the Community, (or several Member States) the words "European Community" may be supplemented by the name of the Member State, (or the Member States concerned), thus "European Community-United Kingdom" or "European Community-United Kingdom, France", etc., as applicable.
- (ii) For goods of non-Community origin insert the name of the individual country of origin. Do not use area groupings such as the European Free Trade Association (EFTA)

- The certificate and the application must not contain erasures or superimposed corrections. Alterations are to be made by crossing out the
 erroneous entries and adding the correct entries as required. Any such alteration must be authenticated by the person making it and endorsed by
 the competent authorities.
- A horizontal line must be drawn immediately below the final entry. Lines must be drawn through unused space to make any subsequent addition impossible.
- If the needs of the export trade so require, one or more extra copies of this certificate may be made.
