EGYPTIAN DOCUMENTS

Shipments into Egypt must be accompanied by a Certificate of Origin and legalisation of the COO document is said not to be mandatory if the goods originate within the UK or a single Member State of the EU. In practice, unless you are absolutely sure this will not be questioned by customs on arrival into Egypt, exporters are recommended to obtain legalised CO documents regardless of the origin.

An ATA Carnet is a temporary export document that is used primarily for goods being temporarily exported for display at trade fairs or exhibitions, and for professional equipment and samples. The ATA Carnet eliminates the need for a customs declaration at the border points and the deposit of a guarnetee, bond or cash desposit in the country of temporary importations. An ATA Carnet can be obtained using the Chamber of Commerce network and although we are not an issuing chamber, we do have arrangements with other issuing Chambers to issue ATA Carnets on our behalf.
